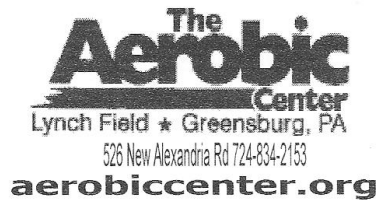

**INDOOR POOL RENTAL POLICIES**

1. Cost for no more than 25 children and adults is \$300.00 or up to a total of 35(max) children and adults is \$350.00. **The fee must be paid the day of the initial reservation.** Cash or credit card only.
2. There will be a **\$25.00 cancellation fee** for any event cancelled with in 7 days. \$20 (8-14 days) \$15 (14-21 days).
3. Parents must provide buoyancy equipment (life vest or swim device) if the child does not have swim ability. Please inform the lifeguard of this.
4. The host/ hostess and guests will be required to **adhere to all Aerobic Center Pool Policies.**
5. Guests may enter through the Aerobic Studio entrance no earlier than 30 minutes prior to scheduled party time. At scheduled party time, guests may enter the pool entrance near caboose.
6. Guests and chaperones are only permitted in the pool area and the Aerobic Studio and are asked to stay in the pool area until it is time to move to the party room. Guests are not permitted to be walking through the Aerobic Center without an escort.
7. **Decorations are permitted** in the Aerobic Center Studio. Absolutely NO TAPE on the mirrors. Host/hostess may enter the Aerobic Studio 30 minutes prior to the scheduled pool party time.
8. No one is permitted in the pool until the lifeguard has reviewed all the rules and regulations with the guests.
9. We encourage you to invite chaperones that will get into the water with the kids. **Children five years of age or younger must be accompanied by a swimming adult.** The lifeguard has the right to refuse entry or removal from the pool for any child with questionable swimming ability.
10. Chaperones are **responsible for assisting younger** children in the locker room.
11. Chaperones are asked to **assist the lifeguards** in keeping the children's behavior under control at all times to maintain a fun and safe atmosphere.
12. **Rafts are not permitted** in the pool. The Aerobic Center will provide a radio, volleyball net, balls and noodles.
13. The host/hostess is responsible and **liable for any damages** that may occur to the pool, studio, equipment and/or facilities.
14. No alcoholic beverages permitted on the premises.
15. The host/hostess is responsible for **supplying beverages and cups.**
16. The **Aerobic Center** is responsible for **providing plates, napkins, tablecloths and utensils.**
17. Six large pizzas are ordered for the children. **If additional pizza is needed it will be the responsibility of the host/hostess to order and pay for it.**
